Once approved by OTCC, please post a notice (see form attached) at the beach pavilion (upright post) one week in advance to alert regular beach users of the planned event.

You are reminded of the need to exercise reasonable care so as not to interfere with the enjoyment of the beach by other OTCC members on the date of your event. The completion of this form, and subsequent approval, is not intended to be a “reservation” but rather a notification of the requested event. Other members cannot be denied access on the day of your event.

Current beach tags shall be worn by the host family and any other Taunton Lake residents.

PLEASE NOTE THAT THE POSSESSION, USE OR CONSUMPTION OF ALCOHOLIC BEVERAGES AND ILLEGAL DRUGS ARE PROHIBITED ON OTCC PROPERTY.

**CONSENT, RELEASE & HOLD HARMLESS AGREEMENT
FOR USAGE OF OLD TAUNTON

The Released Parties are The Old Taunton Colony Club, their respective parent, related, affiliated, and subsidiary organizations and the officers, directors, employees, agents, representatives, successors, and assigns of each. I/we understand that this release and indemnity includes any claims based on the negligence, action or inaction of any of the above Released Parties and covers bodily injury (including death) and property damage, whether suffered before, during, or after such usage.

This Agreement shall be binding upon me/us and my/our heirs, personal representatives and assigns and shall be governed by and construed under the laws of the State of New Jersey. This Agreement constitutes the entire agreement among the parties with respect to the subject matter of this Agreement and supersedes any and all previous agreements among the parties, whether written or oral with respect to such subject matter.
